I understand that I am participating in tournament, recreation, education and cultural arts activities of Hwa Rang Kwan Sonoma at my own risk and if I am injured, Hwa Rang Kwan Sonoma's third party medical insurance will not cover injury resulting from or aggravated by a preexisting injury or illness.
